

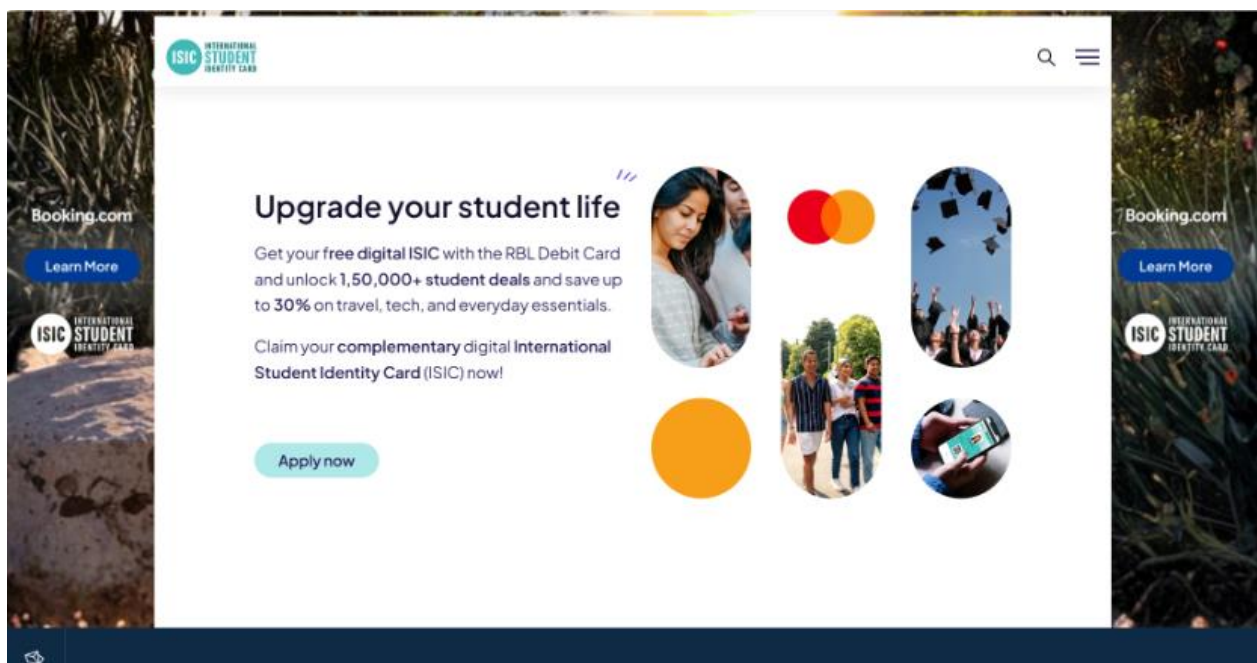
## Step-by-Step Guide: Apply for ISIC with RBL Revelio Debit Card

Start by clicking the link below to begin your ISIC application process.



### Step 3: Check Eligibility



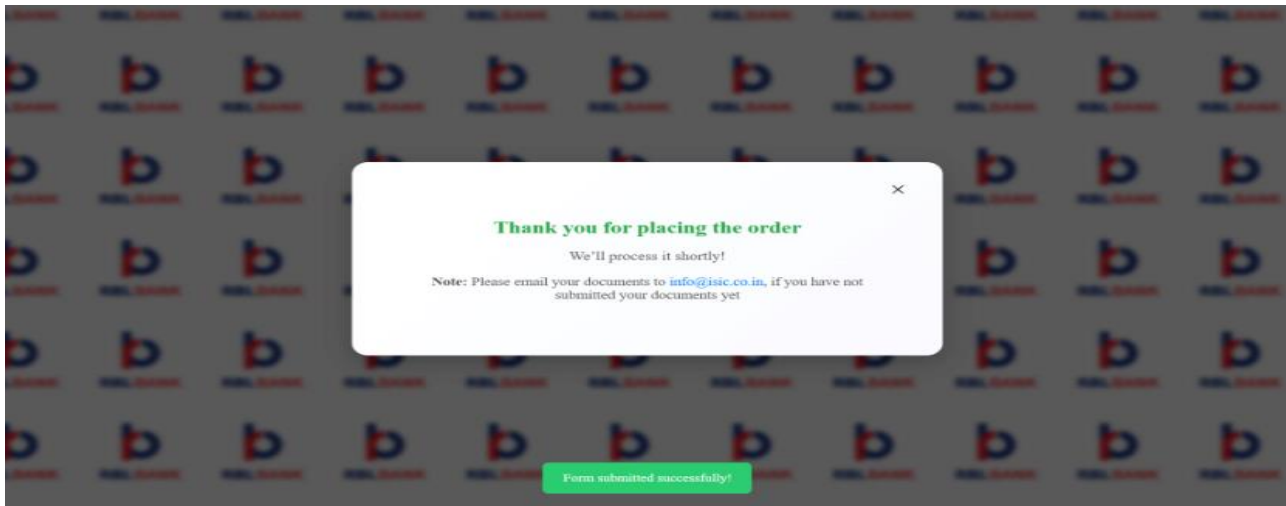

## Step 5: Confirmation



After clicking '**Submit**', you will see a confirmation message thanking you for placing the order. This means your application has been successfully submitted and will be processed shortly. You will also receive a confirmation email stating that your ISIC card order has been confirmed.

Next, the service provider will review the details you have submitted. If everything meets the required standards, they will proceed with processing your application. In case any clarification or additional information is needed, they will reach out to you promptly.

Once all details are verified and approved, the service provider will take approximately 24-48 hours to complete the processing of your application. After this, you will receive your digital ISIC membership credentials along with a comprehensive guide outlining the next steps and additional instructions to help you get started seamlessly.
