Pursuant to the applicable provisions of the SEBI Listing Regulations, we hereby inform you that basis the recommendations of the Nomination and Remuneration Committee, the Board of Directors of the Bank at its meeting held today i.e. December 08, 2025, has *inter-alia* considered and approved the re-appointment of Mr. Chandan Sinha (Part-time Chairman) (DIN: 06921244) (whose initial term of 5 years as a Non-Executive Independent Director as approved by the shareholders will complete on May 20, 2026) as Non-Executive Independent Director of the Bank, for a second consecutive term of three years with effect from May 21, 2026 up to May 20, 2029, i.e. till the completion of his eight continuous years as Director on Board of the Bank, under Section 10A (2A) of the Banking Regulation Act, 1949. The Bank would be seeking the approval of the Shareholders of the Bank for the same.

In terms of Section 149(13) of the Companies Act, 2013, Mr. Chandan Sinha shall not be liable to retire by rotation.

Mr. Chandan Sinha is not debarred from holding the office of Director by virtue of any SEBI order or any other regulatory/statutory authority.
